In the event Seller is forced to retain an attorney to collect any amount due it, each of the parties signing this agreement agrees to pay (in addition to all sums due Seller for the price of said merchandise and service charges) all expenses incurred by Seller. In the event that Seller commences any legal proceedings or action to enforce such collection, Customer further agrees that Customer will pay all necessary and proper costs and charges paid or incurred by Seller in connection with said legal proceedings or actions, including such sums as the court may adjudge reasonable as attorney fees in such proceedings or actions.

Even if Customer is a corporation, partnership or other entity, each person signing this Credit Application understands that he is individually and jointly and severally liable with Customer for all obligations owing from Customer to Seller. Each person signing this Application understands that his liability is continuing and shall remain in force until such time as Seller receives written notice terminating liability for purchases made or obligations incurred by Customer after the date Seller receives such notice.

Each of the undersigned represent that the information contained in this Application is true to their best knowledge and understand that Seller will retain this Application whether or not it is approved. Each person signing this Application authorizes Seller to check bank account, credit and employment history and to answer questions about such person's credit experience with Seller.
